- 8. **Committee Thanks**. Ian Barber gave a special mention to one member (Sylvia Murdoch) who was leaving the Committee, after 5 years. He gave his personal thanks for all the hard work she had put into the u3a, the support given to the Committee and the enthusiasm in helping new members settle in to our u3a. This all helped a healthy and thriving u3a. These thanks were fully supported by members displaying a round of applause.
- 9. **Any Other Business**: The Minutes Secretary (Duncan Fraser) reported that no questions had been received by the deadline of 26th November 2022.
- 10. Prior to the AGM officially starting, Ian Barber requested a minute's silence for those who had passed away since the last AGM.
- 11. The meeting ended at 1049 am. 79 members attended, plus we received 2 postal votes.

3. Chairperson's Annual Report 2023.

During the year the cry went out for volunteers to fill various roles and we were rewarded with Bob Macintosh who stepped up to take over from Sophie as Treasurer. Sophie moved over to pick up the baton of Events Officer. Val Croudass replaced Sylvia as New Members Officer, and Rosemary David has taken on the role of publicity.

At the last AGM, Calvyn Price returned to the General Committee and set about designing a new website for us. This was very fortuitous as no sooner had he completed the task, the **u3a's** National Website, we had previously relied on, crashed. Our new website is a real asset to our **u3a**. My thanks go, not only to these individuals for stepping up and offering their time, but also, to all the other committee members who collectively have served over this past 12 months to keep our **u3a** alive.

One change that will have escaped your notice has been the move of our equipment store from Cheltenham to Tewkesbury. Your **u3a** has a collection of equipment for use by its groups. If your group is ever

4. Membership Secretary's Annual Report 2023

At the time of writing (September) we have 563 members (579 last year). Since the last renewal meeting in November '22 there have been 61 new member applications but inevitably some existing members have not renewed for one reason or another.

Over 80% of members now have internet access but for the past few years, about half of members have chosen to pay their membership fees by cheque, either through the post or at a General Meeting. It would make things a lot easier for the Treasurer and the Membership Secretary if those who could, paid via the internet, either by Bank Fast Transfer or by PayPal. We now have a card reader which should make paying easier at General Meetings.

5. Treasurer's Annual Report for financial year ending 31st August 2023

In early December 2022 our Treasurer, Sophie Franklin, decided that she could no longer continue in post, but would stay to see in a replacement. After several appeals, in February 2023 I agreed to take over the role, and it has been a bit of a learning curve, but at least the u3a continues to function. My thanks go to Sophie Franklin, Duncan Fraser, and Terry Clynes for helping me to pick up the reins.

The figures below, though not approved externally at the time of writing (September), show that finances remain strong. They are broadly similar to the previous year. We have spent slightly more than our income, but this is not significant, since the Charity Commission have told us that our reserves are higher than they would expect for a group of our size and that we should reduce them. To this end, we have encouraged the groups to identify equipment which will support them and funded that. We will continue to do this through the coming year. We have enough to do this and cover any foreseeable commitments.
