## u3a TEWKESBURY AND DISTRICT - MINUTES OF 33<sup>rd</sup> ANNUAL GENERAL MEETING ON MONDAY 9<sup>th</sup> DECEMBER 2024

- 1. **Apologies**: Elizabeth Peche, June Flude, Peter Jones, Jenny Barr. Total members present: 110 (quorate). No motions for the AGM had been received and no voting forms for committee posts were received.
- 2. **Minutes of the 32nd AGM on Monday 11th December 2023:** had been circulated prior to the meeting. The Minutes were proposed for acceptance and publication.

(Proposer: Ken Flude; Seconder: Barry Minett-Smith). *Matters Arising: none.* Motion accepted by majority vote.

- 3. **Chair's Annual Report:** had been circulated prior to the meeting. (Proposer: Val Croudass; Seconder: Shirley Channing). Motion accepted by majority vote.
- 4. **Membership Secretary's Annual Report**: had been circulated prior to the meeting. (Proposer: Linda Whittaker; Seconder: Pauline Dickinson). Motion accepted by majority vote.
- 5. **Treasurer's Annual Report:** had been circulated prior to the meeting. (Proposer: Jean Turner; Seconder: Sophie Franklin). Motion accepted by majority vote.
- 6. **Nomination of Auditor:** that Devereux and Hunt should again be appointed independent examiners for the coming year. (Proposer: Ken Flude; Seconder: Sylvia Murdoch). Motion accepted by majority vote.
- 7. **Proposed Committee Changes**: There were two changes from the previously published proposed new Committee. The Treasurer Robert Mackintosh was sadly seriously ill and could not carry on, so a replacement was urgently needed. In addition, the candidate for Publicity Officer had withdrawn their nomination.

8. Thus, there were vacancies for both the Treasurer and Publicity Officer roles. In such circumstances, our u3a Constitution allows for volunteers from the floor to be nominated. A short job description of both roles was given. Sophie Franklin volunteered for the Treasurer role for a few months on an interim basis until a permanent post holder could be found. (Proposer: Pauline Dickinson; Seconder: Dianne Walker.) Motion accepted by majority vote.

There were no volunteers for the Publicity Officer role. To fill the roles on a permanent basis, both posts would be advertised. Anyone interested should contact the Committee

- 11. Ian Barber then requested a minute's silence for those who had passed away since the last AGM.
- 12. **Committee Thanks**. The new Chairman Ian McHardie-Jones gave Ian Barber and Duncan Fraser a small token of appreciation for their long years of service and commitment to the u3a. This was supported by all members with a strong round of applause.
- 13. The meeting ended at 10.51. 110 members attended.

## 3. Chairperson's Annual Report 2025

I'm coming close to surviving my first year as Chairperson of Tewkesbury and District u3a. "Challenging" could be one word to describe the journey so far. With six Committee Members to replace, including the Treasurer's job after the untimely passing of Bob Mackintosh in January. Although I never had the privilege of working with Bob, he did a wonderful job. This year Liz Peche joined the Committee as Business Secretary, Katie Rowan took up the mantle as Treasurer, Sophie Franklin our Events Officer, became a Committee Member too, plus Shirley Channing took up the new position of Accessibility Officer.

Since taking up the Chairpersonship from Ian Barber (a hard act to follow), I've tried to adopt a "visible, accessible, hands on" approach by attending as many events as possible and doing my best to visit all group activities by the end of the year. So far, so good. Behind the scenes we are looking at ways of supplying Group Leaders with up-to-date information on venue costs and income collected. One good example of this is the Mah-Jong Group. They have recently moved to a more comfortable venue at two

thirds of the cost, win, win! There are other cost centres currently under review including our storage facility. The aim of all these exercises is to examine ways in which we can sensibly make savings without compromising facilities and the services they offer. This should result in better use of u3a funds, with hopefully more money available for members to use, if, or when required.

The Monthly Speakers' Meetings are as popular as ever, with a selection of very interesting topics. My favourite so far.... The Great Train Robbery. Those members who regularly attend will be relieved to know that they won't have to listen to me droning on about Committee vacancies anymore because I'm delighted to say they are all filled. My heartfelt thanks to those members who have stepped up to the plate. Cribbage and Theatre Visits have been added to our activities list. Please support Katie and Pam respectively so that these two new ventures can get off ground. Contact details are in TUTA News. My thanks to those Group Leaders who have stepped down this year for their hard work and dedication. To those who have taken their place, thank you and good luck.

Finally, to my fellow Committee Members who are "retiring" this year: Richard Hart, Neil Leyden, Justin Gowthorpe and George Webb. Thank you for your help, understanding, guidance and support over the past year. I will miss you all. Can I take this opportunity to wish all u3a members a Happy Christmas and an enjoyable u3a New Year.

#### 4. Membership Secretary's Annual Report 2025

At the time of writing we have 609 members (597 last year). Since the last renewal meeting in November '23 there have been 89 new member applications but inevitably some existing members have not renewed for one reason or another.

67% of members have their TUTA News posted to them and just 50 people subscribe to the Third Age Trust magazine, u3a Matters.

Most membership payments are now made online using PayPal or bank

transfer and the use of the card reader for payment at general meetings is very popular.

I have now come to the end of five years on the Committee and will hand over to my successor at the AGM in December.

# 5. Treasurer's Annual Report for financial year ending 31st August 2025

Tewkesbury and District u3a continue to maintain a healthy balance sheet. We have reduced our funds to be nearer the Charity Commission guidance for a charity our size. Although we have had to withdraw some funds this year when our bank balances ran low and we needed some funds to continue paying bills at that time.

We have also continued to suspend the 50p members charge for the monthly General Meetings and the 50p levy per person attending each group activity/session.Our main income comes from our annual membership fee bringing in about £7000, but £3000 of this goes to the national u3a as our affiliation fee

This year, there have been some significant purchases – replacement laptops for committee members, equipment to support groups to function better and the cost of printing and postage of our excellent TUTA news. To advertise our groups in local publication such as Tewkesbury news also comes at a cost to us. The cost of venue hire for many of the groups is covered by individual fees charged to their participants.

We continue to regularly monitor costs and the hire charges Although not yet approved by our external examiner at the time of writing (2/10/25), the following figures show we have a positive balance which enables us to continue functioning and cover any foreseeable commitments.
